MMAC reported 101 new dental providers in FY2022 and 184 FY2023. According to the claims data, 845 of enrolled dentists billed and provided services in FY2023 which is an increase of 102 providers providing services and more importantly, 50,180 more Medicaid recipients had dental services.



BY THE NUMBERS

DENTAL SEALANTS

Dental sealants act as a shield for your teeth. They are thin, protective coatings that are applied to the back teeth, because the chewing surfaces are hard to keep clean. Teeth with sealants are less likely to be affected by germs and food, making it easier to avoid tooth decay. School-based sealant programs are an effective way to deliver preventive services to children who otherwise may not receive them. These services also help families save time and money!

OUR PROGRAMS

The Missouri Department of Health and Senior Services funds school-based oral health programs that offer a variety of dental services in preschools and schools with a high number of children from low-income households. All programs provide services to help prevent cavities, such as fluoride varnish treatments, while some programs provide restorative services such as fillings.


CDC Sealant Program 10,500 Sealants Placed

- CDC Funding of \$354,000 per year for five years, we hope to renew the grant in August 2024.
- Goal to provide sealants to students in high risk schools.
- Schools that had more than 50% of children on Free or Reduced Lunch Program (FRLP) participants.
- 90 schools have provided 4,293 student screenings
- Five Contractors, UMKC, Jefferson County HD, Lincoln County HD, Missouri Southern State University, and recently added St. Louis Community College.






Gender Sealants Present

Treated with Flouride Varnish




Teeth Sealed by Sex



- Develop a sustainable program.
- May include hygiene services delivered in the home.

Teledentistry Pilot

- Teledentistry elevates the level of services to elementary schoolchildren
- In August 2024, a teledentistry pilot will begin in Benton Elementary School and Goodman Elementary School
- Teledentistry services will be provided in partnership with Freeman Neosho Hospital, which has an existing telemedicine agreement with the Neosho School District



Teledentistry

- Telemedicine carts are used to connect with and transmit information to providers
- Multiple attachments are available for the carts
- KCU College of Dental Medicine purchased 10 dental lenses through a grant
 - The dental lenses attach to the existing Horus Scopes used at the schools
- All services will be provided only with parental consent and protocols will be in place to safeguard patient confidentiality
- Children without a dental home can be seen at KCU's
 Oral Health Center to have their oral health needs met

First-Aid/Trauma Kits

- ODH has purchased items through the Maternal Child Health Block Grant for a Dental First Aid/Trauma Kit for each school in Missouri.
- ODH assembled over 3,000 kits delivered throughout the state for school nurses.
- The kits also include a dental trauma handbook for references in dental emergencies.



First-Aid/Trauma Kits

I would like to send a HUGE shout out to DHSS and the MO Office of Dental Health. I attended a school nurse event and received a dental trauma kit for our health office. Little did I know that we would be using the kit just a few months later. We had a student visit our office with a central tooth avulsion (upper front tooth was completely knocked out) after being hit by a ball. Human Papilloma Virus (HPV)

- HPV is responsible for the recent surge in head and neck cancers.
- The American Dental Association, American Academy of Pediatrics, CDC and many other agencies and organizations recommend HPV vaccine for prevention of HPV infection.
- ODH is partnering with the Bureau of Immunizations to promote HPV vaccinations.
- ODH is working to educate dentists in talking with their patients 9-26 years of age about the importance of the HPV vaccine in preventing cancer.

Dental Assistant Pipeline

Develop a Dental Assistant Pipeline through Missouri High School Career Centers (HSCC)

- 1. ODH project funded by Delta Dental (\$100,000).
- In cooperation with an HSCC, develop a 10-month educational pilot program for high school juniors and seniors. Planned start for Fall 2024 in Pike/Lincoln and St. Charles County Career Centers
- 3. Would allow students to graduate with high school diploma and dental assisting certificate, in the future, we would like to add expanded functions dental assistant certificates.


Oral Preventive Assistant-EFDA

Develop an Oral Preventive Assistant (OPA)-EFDA

- 1. ODH has received the authorization from the MDB to start this pilot project to address workforce shortages, to be carried out by the ODH and the MDB.
- 2. OPA EFDA would deliver oral health instruction and preventive care, including supragingival scaling on patients, under direct supervision of a dentist or hygienist.
- 3. Pilot would include curriculum development, training, testing and measurement with reporting to MDB and ODH.



Impact of PSP Program - Fluoride Varnish Program (based on 2022 data)

- Estimated reduction of dental decay of Medicaid patients is about 7%. Overall reduction of 4%.
- Identification of schools and areas that are having problems accessing dental care by the Untreated Decay rate.
- JADA: Topical Fluoride Impact in Future Restorative Dental Procedures. The application of fluoride varnishes and gels increased the time to future restorative and extraction dental claims and decreased the number of future restorative and extraction dental claims.

Exciting changes to our PSP events and structure

- 1. Dentists.
- 2. Dental Students (Competency as determined by faculty of respective dental school, typically third- or fourth-year students).
- 3. Dental Hygienists.
- 4. Dental Hygiene Students (Competency as determined by faculty of respective dental hygiene program, typically second year students).
- 5. Dental Assistants (Certified Dental Assistant or passage a Missouri Dental Assisting Basic Skills exam and/or a minimum of two years chairside experience).
- 6. Licensed Medical Professionals (i.e., Physicians, Nurses, Nurse Practitioners, etc.).
- 7. Medical Professional Students (Competency as determined by faculty of respective medical or nursing program).
- 8. Community Health Care Coordinator or Community Dental Health Care Coordinator.

PSP Restructuring

• With expected increases in our PSP reach and events, we are in the process of reorganizing our PSP structure.

• We are streamlining the PSP team, from five part-time staff to 2 full-time staff for enhanced efficiency and focus—effective 10/1/2024





Basic Dental Screening Survey (BSS) or Oral Health Conditions in Third Grade Students-2019

- A randomized, standardized survey of the oral health of third grade students in Missouri.
- Third graders have a mixture of permanent and deciduous (baby) teeth.
- They are old enough to cooperate to be seen by most dentists.
- They are old enough to perform their oral care independently.
- We are currently conducting the BSS for the 2023-2024 school year





CWF updates in the state

- Branson voted to discontinue fluoridation on Nov. 14, 2023
- Lake Winnebago voted to continue fluoridation on Nov. 15, 2023
- Independence has come to ODH to consider initiation of fluoridation
- Versailles would like to discuss CWF in 2024
- ODH has started conversations with all of these systems
 - North Central Wholesale Water Commission (35,000 people)
 - Tri-County Wholesale Water Commission (100,000 people)
 - Clarence Cannon Wholesale Water Commission (85,000 people)
 - Butler Co PWSD 1 (5,000 people)
 - Piedmont Public Works (Have fluoridation equipment and would like to possibly start fluoridation) (2,000 people)
 - Brunswick Water System (sells to another system) (4,000 people)

Community Water Fluoridation: A Plan for Missouri



Opioid Settlement **Funds** New **Decision** Item (NDI) \$3,840,000

- Medicaid benefits do not include tooth replacement unless you are pregnant, blind, disabled or in nursing home
- Treatment and recovery programs report having difficulty finding sufficient funding and dental treatment resources for all of the individuals in recovery who need them.
- Substance use disorder (SUD) results in poor oral health and loss of teeth
- Unmet oral health needs increase in costs for dental treatment, potentially for treatment/relapse intervention, and for negative psychosocial impacts on the individual and their family.
- Proposed the addition of two community dental health coordinators (CDHC) to help coordinate dental care for their clients.
- \$3,760,000 would go directly for dentures, partials and bridges not covered by Medicaid.
